- A minimum of 10 people from my immediate jurisdiction are not interested in forming a lodge and
- If within the At Large Lodge 10 members are from the same immediate jurisdiction, those members will transfer out of the At Large Lodge and charter a new lodge in that jurisdiction and
- The current Executive Board of the Kansas State Lodge will be the officers of the At Large Lodge and
- I understand that as a member of the At Large Lodge, membership in the FOP Legal Defense Plan is mandatory. I agree to this, as a condition of my membership in the FOP At Large Lodge.

I, the undersigned, a full time, regularly employed law enforcement officer, do hereby make application for Active membership in the At Large Lodge in Kansas Number 55. If my membership should be revoked or discontinued for any cause other than retirement while in good standing, I do hereby agree to return to the State Secretary; my membership card and any other material bearing the F.O.P. insignia, such as auto emblem, lapel pin, etc.
